7. The P&I Clubs / Insurers will be approved for a period of five (5) years, subject to renewal, from September 06, 2019.
8. The requirements for a P & I Clubs or Insurers companies to be approved by Panama Maritime Authority to issue the financial securities required by the MLC are as follows:
  - 1) Description of full coverage amount of the applicant
  - 2) Description of the organization
  - 3) Description of years in the maritime market
  - 4) Description of the reinsurers
  - 5) Full description of her client portfolio
  - 6) Description of the number of vessel and particulars insured (for our reference)
  - 7) Description of Financial reports and presentation
  - 8) Statement of approved letter by other administration to act on her behalf
  - 9) Affiliated companies Abroad
  - 10) Official payment receipt.
9. Financial Securities shall be reissued by the P&I, Insurer or Guarantor due to change of ship's, shipowner, gross tonnage (as required by the WRC 2007) and other reasons; therefore, previous Financial Securities shall be cancelled as well as the correspondent Certificate (if applicable).
10. Approved P&I, Insurer or Guarantor changing its name, address and other relevant information must provide the correspondent documents explaining such changes, and a new payment.
11. The financial security related to CLC'92, BCC 2001, PAL 2002 and WRC 2007 shall not cease to be valid before the end of the period of validity of the financial security unless the P & I Club or Insurer provide a notification or cancellation notice prior to 3 (three) months from the date on which notification has been received by the General Directorate of Merchant Marine. 12. 14. The certificate or other documentary evidence referred to MLC 2006 Financial Security for shipowners' liability required under the Standard A4.2.1 shall include the following information:

- Name of the ship,
- Port of registry of the ship,
- Call sign of the ship,
- IMO number of the ship,
- Name and address of the provider or providers of the financial security,
- Contact details of the persons or entity responsible for handling seafarers' contractual claims,
- Name of the shipowner,
- Period of validity of the financial security (P&I Club or insurer) y; and
- An attestation from the financial security (P&I Club or insurer) meets the requirements of Standard A4.2.1.
