## MERCHANT MARINE CIRCULAR MMC-175

- To:** Parties, Administrations, Port State Control Authorities, Ship-owners/Operators, Recognized Organizations (RO's), Seafarers, Legal Representatives, Authorized Maritime Training Centers, Authorized Medical Practitioners (MD), Privative Consulates of Merchant Marine of the Republic of Panama, Inspectorates, Auxiliary Registry Offices, Authorized Offices, Brokers, and users of the Panama Ship Registry.
- Subject:** Crew Dispensations under the Article VIII of the 1978 STCW Convention, as amended.
- Reference:** 1978 STCW Convention, as amended; Law No. 4 of May 15, 1992; Resolution J.D. No. 076-2020 of October 8, 2020 and its modifications, and Resolution ADM No. 072-2021 of April 30, 2021.

### 1. Purpose

- 1.1. The purpose of this Circular is to communicate to the users of the Panamanian Registry, that, in accordance with Article VIII of the 1978 STCW Convention, as amended, the Panama Maritime Authority may, in circumstances of exceptional necessity, issue a Dispensation permitting a specified seafarer to serve in a specified ships for a specified period, if in our opinion this does not cause danger to persons, property and the environment.

### 2. Scope

- 2.1. These provisions apply to all seafarers serving on seagoing ships registered under the Panamanian flag; ship-owners, operators and companies of Panamanian flag ships and to all interested parties, under the provisions of the 1978 STCW Convention.

3. The General Directorate of Seafarers of the Panama Maritime Authority is in charge of the issuance of Dispensation under the Article VIII of the 1978 STCW Convention, as amended.
4. Requests for the Dispensation under the Article VIII of the 1978 STCW Convention, as amended will be directed to the Headquarters or the Regional Documentation Offices (RDO) of the General Directorate of Seafarers, to the contact information detailed below:

5. The Panama Maritime Authority establishes that the Dispensation under the Article VIII of the 1978 STCW Convention, as amended, will be issued in the following situations:
  - 5.1. Force Majeure Cases.
  - 5.2. Family Reasons.
  - 5.3. Medical Reasons.
  - 5.4. Special Circumstances.
6. The Panama Maritime Authority determines that for the positions of Master and Chief Engineer, a Dispensation under the Article VIII of the 1978 STCW Convention, as amended, may only be granted in cases of *force majeure* and for periods, as short as possible.
7. The Dispensation granted under the Article VIII of the 1978 STCW Convention, as amended, for positions other than those established in paragraph # 6, shall be issued for a specified period, not exceeding six (6) months.
8. No Dispensation shall be issued under the Article VIII of the 1978 STCW Convention, as amended, for the positions of Radiotelegraph Officer and Radiotelephone Operator, unless the relevant circumstances established in the Radio Regulations occur.
9. The beneficiary of the Dispensation shall be competent for the position for which the Dispensation is granted under the Article VIII of the 1978 STCW Convention, as amended, with the condition of its competence being enough to fill the vacant position without risks, to the satisfaction of the Panama Maritime Authority.
10. To request a Dispensation under the Article VIII of the 1978 STCW Convention, as amended, the company will comply with the technical and administrative requirements established by the General Directorate of Seafarers and complete the application form, available in the following link:

11. In exceptional cases, the Panama Maritime Authority may issue an Authorization Letter under the condition of “Home Country License”, in accordance with the following situations:

11.1. Single voyage for ship delivery.

11.2. Damage or loss of technical documentation issued by the Panama Maritime Authority to the Seafarers.

11.3. Special Circumstances.

12. To request an Authorization Letter, the company must comply with the technical and administrative requirements established by the General Directorate of Seafarers and complete the request form, available in the following link:

13. The companies shall request the Dispensation under the Article VIII of the 1978 STCW Convention, as amended, as well as the Authorization Letter opportunely and with as much advance notice as possible notice and in a timely manner.

14. The Panama Maritime Authority may issue an **Attesting Letter** for the purpose of attesting the technical documentation for seafarers, issued by this Maritime Administration, in case it is required by the Port State Control Authorities or any Competent Authority.

15. To request an Attesting Letter, the company must comply with the following requirements:

15.1. Request addressed by e-mail, according to the contact information in paragraph # 4, detailing the situation that supports the request.

15.2. Crew List duly signed and stamped either by the Master or the Company.

15.3. Technical Documentation issued by the Panama Maritime Authority.

15.4. The valid Ship Registry Certificate.
