## 2. PURPOSE

The purpose of this circular is to inform all our stakeholders about the Recognized Organizations (RO) and Recognized Security Organizations (RSO) authorized to perform Statutory Certification and Services on behalf of the Republic of Panama for ships registered under Panama flag.

## 3. SCOPE

- 3.1.** The General Directorate of Merchant Marine, based on the provisions of Law No. 57 dated August 6, 2008, Article 128 is able to delegate to other entities, its faculty to verify and certify Panamanian flagged vessels, according to maritime regulations adopted by this Administration, so that such entities can conduct inspections and issue certificates on behalf of the Republic of Panama, in order to verify that our fleet is fulfilling compliance in terms of safety, security and prevention of maritime pollution.
- 3.2.** Furthermore, through National Resolutions No. 106-OMI-135-DGMM, 106-OMI-136-DGMM, and 106-OMI-137-DGMM, all of them of October 29, 2014, the General Directorate of Merchant Marine adopted the IMO Resolutions MEPC.238(65), MSC.350(92) and MSC.356(92), through which the Recognized Organization Code became mandatory.
- 3.3.** Moreover, through the National Resolution ADM No. 014-2021 of February 17, 2021, this Administration implemented Resolution A.1070(28) IMO Instruments Implementation Code (III Code) – Delegation of Authority, paragraph 18.
- 3.4.** Lastly, through the National Resolution No. 106-023-DGMM of March 30, 2022; the General Directorate of Merchant Marine adopted the regulation to rule, control, and monitor Recognized Organizations and Recognized Security Organizations authorized by the Republic of Panama and those seeking approval as Recognized Organization.
- 3.5.** The aforementioned legislations are the legal basis through which this Administration administers and regulates the delegation of authority for statutory certification and services in accordance with the applicable requirements of the international mandatory instruments.

## 4. DEFINITIONS

- 4.1. Recognized Organization (RO):** Organization that has been assessed by the flag State, and found to comply with Part 2 of the RO Code.
- 4.2. Recognized Security Organization (RSO):** Organization authorized by the Administration to evaluate Ship Security Plans and carry out verifications and issue

Interim International Ship Security Certificate, subject to the provisions of the ISPS Code.

**4.3. Authorization:** Delegation of authority granted to a Recognized Organization to perform statutory certification and services on behalf of a flag State, which could be Full, Partial or Limited.

**4.4. Active:** Recognized Organization having valid authorization to perform statutory certification and services on behalf of a flag State.

**4.5. Suspended:** Recognized Organization having a temporary suspension of the authorization to perform statutory certification and services on behalf and under the conditions of the flag State,

**4.6. Canceled:** Recognized Organization whose authorization has been permanently revoke to perform statutory certification and services on behalf of a flag State.

**4.7. Full Authorization:** Authorization to perform inspections, surveys, audits, plan reviews, approvals, and issue/revoke necessary interim and full-term certificates. This type of authorization shall be permanently authorized through a resolution issued by the flag State and included in the official agreement.

**4.8. Partial Authorization:** Authorization to perform inspections, surveys, audits, plan reviews, approvals, and issue/revoke interim certificates; however, the definitive review/approval and/or Full-Term Certificate is issued by the Administration. This type of authorization shall be permanently authorized through a resolution issued by the flag State and included in the official agreement.

**4.9. Limited Authorization:** Temporary authorization to perform a specific inspection, survey, audit, plan review, approval, and issue interim and/or full-term certificate for a specific ship(s) in cases where the Recognized Organization is not authorized Full or Partial. This authorization will be evaluated and approved through a formal letter, on a case-by-case basis.

## 5. APPLICABILITY

**5.1.** Recognized Organizations shall be in compliance with the RO Code requirements, to perform statutory certification and services under mandatory IMO instruments and national legislation, on behalf of the Republic of Panama.

- 5.2.** All requirements of the RO Code are generics and applicable to all Recognized Organizations, regardless of their type and size and the statutory certification and services provided.
- 5.3.** It is noteworthy that Recognized Organizations do not need to provide all types of statutory certification and services and may have a limited scope of delegation, provided that the requirements of the RO Code are applied in a manner that is compatible with the limited scope of delegation.

## **6. IMPLEMENTATION**

### **6.1. Delegation of Authority**

#### **6.1.1. New Organizations**

- 6.1.1.1.** Companies interested in obtaining authorization as a Recognized Organization, Recognized Security Organization, or accepted as a Classification Society, to carry out statutory certification and services on behalf of the Republic of Panama, shall submit a formal application letter, through its legal representative, to the General Directorate of Merchant Marine of the Panama Maritime Authority. This letter should be accompanied by the documents listed in Article 3 / Article 4 of [Resolution No. 106-023-DGMM of March 30, 2022](#).
- 6.1.1.2.** The evaluation process shall be according to the provisions of Article 9 and Article 19 of Resolution No. 106-023-DGMM of March 30, 2022.
- 6.1.1.3.** Once approved, a reasoned resolution will be issued and the Official Delegation Agreement signed, as a confirmation that the company has been authorized as a Recognized Organization by the Republic of Panama, as stated in paragraph 11 of Resolution No. 106-023-DGMM of March 30, 2022.

#### **6.1.2. Authorized Recognized Organizations**

- 6.1.2.1.** Recognized Organizations duly authorized by this Administration and interested in broadening the delegation of authority (full, partial), shall apply through their legal representative, in a formal letter addressed to the General Directorate of Merchant Marine of the Panama Maritime Authority and accompanied by the documents listed in Article 8 of Resolution No. 106-023-DGMM of March 30, 2022.

**6.1.2.2.** The evaluation process shall be according to the provisions of Article 9 of Resolution No. 106-023-DGMM of March 30, 2022.

**6.1.2.3.** Once approved, a reasoned resolution will be issued, as stated in paragraph 11 of Resolution No. 106-023-DGMM of March 30, 2022.

**6.1.2.4.** Recognized Organizations not having full or partial authorization to conduct a specific inspection, survey, audit, plan review, approval, and issue interim and/or full-term certificate for a specific ship(s), and are interested in doing so, should contact [ro-monitoring@segumar.com](mailto:ro-monitoring@segumar.com) for the evaluation and issuance of a limited authorization.

## 6.2. Oversight Program

**6.2.1.** In order to determine the aspects of managerial, technical, and administrative capacity, competence, capacity, and full knowledge of the work carried out by the Recognized Organizations within the framework of the delegation of authority, based on Resolution No. 106-023-DGMM of March 30, 2022; this Administration has adopted different mechanisms to oversight the Recognized Organizations by conducting:

**6.2.1.1.** Audits,

**6.2.1.2.** Annual Performance Evaluations (i.e., PSC performance, Malpractice),

**6.2.1.3.** Remote monitoring (not regarded as audit),

**6.2.1.4.** Follow-Up Visits,

**6.2.1.5.** Any other activity considered appropriate to carry out the work of supervision and monitoring.

## 6.3. List of authorized Recognized Organizations

## 6.4. Specification of Documents

### 6.4.1. Certificates

Technical Certificates issued by the Recognized Organizations on behalf of the Republic of Panama shall meet the following specifications:

- a. Technical certificates shall follow exactly the format prescribed in the annexes to the pertinent conventions, and written in English.
- b. All of the provisional conventions Technical Certificates issued shall clearly show the name(s) of the surveyor(s) / auditor(s) who carried out the survey / audit, as well as signature(s).

- c. All convention technical certificates shall be signed by the individual(s) duly authorized by the Recognized Organization to do so.
- d. The Coat of Arm of the Republic of Panama shall be printed at the head of each certificate issued on behalf of the Republic of Panama according to the following specifications and as indicated by the convention (state):
  - [Full-color Coat of Arm shall be printed on a green background](#) , or
  - [Gray color](#) or [Heraldic lines Coat of Arm](#).

## 6.4.2. Approvals

According to the provisions of some instruments, certain plans, manuals, booklets, or documents need to be approved by the Administration. In such cases, Recognized Organizations authorized should stamp them with the statement: "Approved on behalf of the Administration". If approvals are not explicitly required by the regulations to be approved by the Administration, they should be stamped as approved on behalf of the Recognized Organizations. Every approval shall be reported as indicated in the MMC-324.

## 6.5. Administrative fee

Information about the Administrative fees for the issuance and approvals of certificates, documents, plans, manuals, and booklets have been set in the following merchant marine circulars:

- 6.5.1. MMC-324** - Control and Administrative Fees imposed by the Republic of Panama to the Technical Documents, Statutory Certificates issued, endorsements and approvals
- 6.5.2. MMC-345** - Ballast Water Management Convention 2004, Panama Policy.
- 6.5.3. MMC-386** - Inventory of Hazardous Materials (IHM) for ships calling at EU ports.

## 6.6. Communication by the Administration
